**MINUTES:** Dean Sirucek made a motion "to approve the minutes of the July 27, 2015 business-meeting as presented." Mark Siderius seconded. Motion carried unanimously.

Mark Siderius made a motion "to approve the bills as presented." Camisha Sawtelle seconded. Motion carried unanimously.

**PUBLIC COMMENT PERIOD:** Richard Sauerbier commended the district board and staff for their professionalism, timeliness and cooperation as he learned the 310 process, even though the complaint he filed was found not to be a violation.

**AQUATIC INVASIVE SPECIES (AIS):** Stephanie Hester, DNRC, reported FWP did a precomprehensive survey on lower Flathead River to assess aquatic invasive species (AIS) curly leaf pond weed & flowering rush. FWP will create a map showing where the infestations are and recommend a plan for eradication.

Dean Sirucek asked if any additional considerations should be listed in a 310 permit if the project is in a potential area where AIS have been located. The current Adopted Rules do not address AIS. Stephanie noted AIS protocols are listed in 124-permits. FCD Supervisors & FWP noted they could be more aware when doing 310 on-site inspections on lower Flathead River.

**HANCOCK**, FL2015033, Swan River, trim brush: Discussion held. Pete Woll made a motion "to approve the application as submitted. The on-site is waived with concurrence by FWP. The 15-day waiting period is waived." Camisha Sawtelle seconded. Motion carried unanimously.

**ILLICH**, FL2014033C (FL2014058), Flathead River, complaint: Discussion held. Ronald Buentemeier made a motion "work has been completed under permit #FL2014058, and the violation is satisfied." Pete Woll seconded. Motion carried unanimously.

**MEHL**, FL2015027, Stillwater River trib., permit modification request: An on-site inspection was set for Tuesday, September 1, 9:00 AM at the site.

**NORTHERN RIDGEBACK LLC**, FL2015043, Abbot Creek, culvert: An on-site was set for Tuesday, August 18, 10:50 AM at the Deerlick.

**PLUM CREEK TIMBER**, FL2015036, unnamed stream, culvert: Dean Sirucek. Verdell Jackson made a motion "to approve the application as submitted." Mark Siderius seconded. Motion carried unanimously.

**VARDELL**, FL2015042, Whitefish River, tree removal: An on-site inspection was set for Tuesday, August 18, 2:45 PM at the site.

**WHITE**, FL2015030, Browns Creek, residential structure: Discussion held. Pete Woll made a motion "to deny the application because of the proximity of the cabin being built between the stream and the tributary; the cabin is proposed to be built within 20 feet of the top of the bank." Mark Siderius seconded. Motion carried unanimously.

Pete Woll made a motion "the fill that was placed between Brown's Creek & the tributary is to be pulled back to the parking area, and exposed areas sloped and seeded to prevent erosion. The applicant is to submit a seeding plan to the FCD." Dean Sirucek seconded. Motion carried with one no vote.

## <u>NEW BUSINESS</u>:

**FLATHEAD BASIN COMMISSION AQUATIC INVASIVE SPECIES (AIS) SUPPORT**: Dean Sirucek reported Flathead Basin Commission (FBC) has operated & funded one of the AIS watercraft inspection stations (WIS) for the last 3 years. This year the station was moved from Coram to Browning, where it checks watercraft east to Reservation waters and west to Flathead waters. The current FBC budget is insufficient, and lack of donations has created a shortfall to fully support this WIS through 2015. The Swan Lakers, Flathead Lakers, and DNRC have contributed some funding; however, they are approximately \$10,000 short of totally funding the station. The Browning station has already stopped 2 boats with AIS this year. Discussion held. Dean Sirucek made a motion "to approve \$5000 from the Watershed Other line in the budget for the Browning AIS station." Verdell Jackson seconded. Motion carried unanimously.

**310 ADMIN GR #CDA-15-1696:** Discussion held. Mark Siderius made a motion "to approve the final report for 310 Administrative grant #CDA-15-1696 and submit to DNRC." Dean Sirucek seconded. Motion carried unanimously.
