MAYPORT HARBOR HO, FL2015059: Mark Siderius informed the board he was asked to bid on the Mayport Harbor project after the 310-meeting when the permit was approved. He was the only bidder, thus he is the contractor for the project.

NEW BUSINESS:

DRAFT EA OF SPA 124 PERMITTING: Discussion held regarding the draft Programmatic Environmental Assessment (EA) for 124-permitting by MT Fish, Wildlife and Parks of culverts, bridges, and removal of beaver dams. Comments will be accepted until December 23, 2015, 5:00 P.M.

FCD 310-PERMIT PROCESS INFORMATION SHEET: Discussion held. Mark Siderius made a motion "to approve the 310 permit process information sheet." Dean Sirucek seconded. Motion carried unanimously.

CPA LETTER OF ENGAGEMENT & ANNUAL FINANCIAL REPORT: Discussion held. Mark Siderius made a motion "to approve the letter of engagement with Susan Hulslander, CPA." Dean Sirucek seconded. Motion carried unanimously.

John Ellis made a motion "to approve the State of Montana Department of Administration Local Government Annual Financial Report for Fiscal Year ending June 30, 2015." Pete Woll seconded. Motion carried unanimously. Per the report, an audit is not required.

Discussion held regarding audit requirements. Per 76-15-315 MCA, district supervisors shall provide for an annual audit; per 2-7-503 MCA, local government entities receiving revenue in excess of \$500,000 shall have an audit. Valerie Kurth will contact DNRC for an interpretation as the codes seem to conflict.



REQUEST FOR RECORDS DISPOSAL: Discussion held. Dean Sirucek made a motion "to approve the Records Disposal request for 2007 records, and send to the Montana Department of Administration - Local Government Records for review and approval." Pete Woll seconded. Motion carried unanimously.

FURNITURE DISPOSAL REQUEST: Discussion held. John Ellis made a motion "to approve the furniture disposal request." Camisha Sawtelle seconded. Motion carried unanimously.

EQUIPMENT PURCHASE/RESOLUTION: Discussion held. Dean Sirucek made a motion "to adopt a Resolution to pay funds out of CIP (Capital Improvements) Fund 7235 in the amount of \$9103.00 to Anders Business Solutions to purchase a Konica Minolta BizHub C308 copier – Digital Color Multifunction System, and trade in the old copier." John Ellis seconded. Motion carried unanimously.

2015/2016 BUDGET ADJUSTMENT: Ginger Kauffman reported that in February, the board had adopted a Repair and Capitalization Policy which stated individual items under \$500 will be deducted as incurred as an operating expense, and individual items over \$500 will be capitalized. Discussion held. 2015/2016 budget amounts for supplies and furniture & equipment will not be adjusted at this time.

FLATHEAD EDUCATOR'S GUIDE GR #223-14-3350: Discussion held. Pete Woll made a motion "to approve invoices totaling \$3200.00 for Flathead Educators Guide grant #223-14-3350, and submit to DNRC for payment." Dean Sirucek seconded. Motion carried unanimously.

TRUMBULL CREEK RESTORATION PROJECT GR #223-12-3239: Discussion held. Dean Sirucek made a motion "to approve the invoice totaling \$1518.75 for Trumbull Creek Restoration grant #223-12-3239, and submit to DNRC for payment." John Ellis seconded. Motion carried unanimously.

KRAUSE CREEK WATERSHED PLANNING GR #RGP-16-0464: Valerie Kurth reported only one bid was received in response to the Limited Solicitation. The review committee and DNRC recommend a more detailed limited solicitation and to extend the deadline. Discussion held. Camisha Sawtelle made a motion "to revise the limited solicitation and readvertise with a deadline of 1/6/2016." Pete Woll seconded. Motion carried unanimously.
