**AQUIFER PRESENTATION EXPENSES:** Mark Siderius reported approximately 250-270 people attended the April 6<sup>th</sup> Deep Aquifer presentation by Montana Bureau of Mines and Geology (MBMG) scientists James Rose and John Wheaton. A copy of the scientist's presentation slides will eventually be posted on the MBMG website.

Mark noted the focus of the April 6<sup>th</sup> presentation was **not** on the proposed bottling plant. However, numerous calls were still received by the Flathead River Commission, Flathead Conservation District and Flathead Valley Community College (FVCC) regarding that issue.

Discussion held regarding FVCC security costs. Mark Siderius made a motion "to approve the invoice from FVCC for security of the Deep Aquifer presentation in the amount of \$240." Verdell Jackson seconded. Motion carried unanimously.
