Camisha Sawtelle asked Mikel Siemens and Marcel Quinn about the work that is continuing at the site. Mikel stated they are in low flow conditions and are working in compliance with other permits (DEQ). Valerie Kurth will request a copy of Stalow’s DEQ permit.

The board asked Marcel about Army Corps of Engineers (ACOE) permits. Marcel stated ACOE had previously made a non-jurisdictional decision. Marcel stated current work is limited to beaver pond/the wetland area. The dredging project is to move the stock piled material in the pond. Measures are being taken to handle run off. Work will continue as described in previous permit applications.

The board asked Caitlin Overland about a conservation district’s authority to issue a stop work order. Caitlin will look up the rules and contact FCD.

Dean Sirucek made motion “at the meeting that the Stalow 310 technical review is discussed, we request Don McIntyre’s and Caitlin Overland’s presence. We request they be in the district office one hour before the meeting.” John Ellis seconded. Motion carried with one no vote.
