PUBLIC COMMENT PERIOD: Patrick Sullivan, Swift Eagle Ranch, reported the neighbor across the stream (Foley) did an emergency 310-permit several years ago for bank stabilization on Swift Creek. One of the logs used in the stabilization project has recently moved into the stream channel and now the bank is eroding on the Swift Eagle Ranch side of the stream. He said had talked to Ronald Buentemeier about a notice of emergency, but needs permission from Foley before beginning work to move the woody debris back to Foley's side of the stream before high water. Mr. Sullivan passed around photos. Discussion held.

DEEP AQUIFER PRESENTATION: Bob Storer, Flathead River Commission, thanked the board for supporting the upcoming presentation by Montana Bureau of Mines & Geology on April 6, at FVCC. Tom Esch stated the USGS maps show Bear Creek goes through the project, and noted the boardwalk was permitted by the FCD. The project is delayed at this time, but recently the stream was flowing and showed some turbidity. Mr. Esch also asked that the Flathead CD assert jurisdiction.
